



# 2018 National Poll on Afterschool Topline Questionnaire

October 2018

Polling results are from a Lake Research Partners and The Tarrance Group designed survey conducted online in Ipsos's Omnibus using the web-enabled "KnowledgePanel," a probability-based panel designed to be representative of the U.S. general population. The survey was conducted between September 7-9, reaching 1,001 adults nationwide and has a margin of error of +/- 3%.<sup>1</sup>
