
- 30,720 households screened, 56,252 children screened and 13,709 in-depth responses
- Online survey using a blend of national consumer panels
- Data collected between Feb. 28 and April 17
- Minimum of 200 in-depth responses from each state and District of Columbia
- Margin of Error = less than +/- 1 percent

How are kids spending their time after school?

Participation in afterschool programs has grown significantly

Participation in afterschool programs has consistently increased over the past 10 years, **rising by nearly 2 million children** in the last five years alone.

Children in an afterschool program




On average, children in an afterschool program participate **3.62 days** and **7.37 hours** per week

45% of the 10.2 million kids in afterschool programs are from **free/reduced price lunch households**

The number of children unsupervised in the after school hours remains high





Most families piece together a variety of afterschool solutions, with 66% of Florida's K-12 children spending some portion of the hours after school in the care of a parent or guardian. Other afterschool arrangements include traditional child care centers (10%); sibling care (19%); and non-parental adult care, such as a grandparent or neighbor (30%).



Footnotes

In Florida, 543 households and 2,581 children were screened for this study. According to the Department of Education, National Center for Education Statistics data for 2011-2012, the total school enrollment in Florida is 2,864,977, which is the foundation for all statewide projections in Florida After 3PM.


**Arizona Named a 'Top 10 State for Afterschool,'

The Afterschool Alliance's *America After 3PM* report revealed that **178,554 children in Arizona** participate in an afterschool program, yet **318,223 children would be enrolled** in a program if one were available to them.

With **84% of Arizona's parents supporting public funding for afterschool programs**, there remains more work to be done to ensure that all children in Arizona are able to take part in an afterschool program that keeps them safe, inspires learning, and provides their parents peace of mind.

Efforts over the past decade to improve Arizona's afterschool programs have earned the state the sixth highest ranking in a [national report](#) released this month.

A focus on reinforcing school-day lessons through fun and enriching learning opportunities and an increase in access to federally funded grants that support them are key contributors.

After-school programs like these help kids see the relevance of what they learn in class, develop resiliency, and

create the solid social and emotional foundation that academic success is built on, said Melanie McClintock, executive director of [Arizona Center for Afterschool Excellence](#).

"Kids are doing more hands-on projects and they're having their 'a-ha' moment about why the teacher taught them that in quality after-school programs," McClintock said. "Whether it's using math to build a race car or launch a rocket, it's a direct application of concepts learned in the classroom."

Arizona's after-school programs are ranked sixth in the nation, according to "[America After 3 p.m.: Afterschool Programs in Demand](#)" recently released by the [Afterschool Alliance](#).

The Afterschool Alliance's 2014 America After 3 PM report recently ranked Arizona 6th in the nation for youth participation in and parent satisfaction with afterschool programming statewide, giving Arizona much to celebrate this year.

- 178,554 children in Arizona participate in an afterschool program
- And another 318,223 would be enrolled in a program if one were available to them.
- The 6.79 hours average time per week Arizona youth spend in afterschool programs exceed the 5.64 hours average time youth are left unsupervised afterschool

High parental satisfaction with and support for quality afterschool programs are also reasons to celebrate.

- 97% of Arizona parents are satisfied with their child's afterschool program
- 72% of Arizona parents agree that afterschool program can help excite youth about learning, and
- 71% of Arizona parents agree that afterschool programs help youth gain workforce skills, such as teamwork, leadership and critical thinking.

About the Survey

America After 3PM is the largest national household survey. 37,720 households were surveyed online, covering 56,252 children and receiving 13,709 responses. Data was collected 2.28.2014 - 4.17.2014. The Afterschool Alliance contracted with Shugoll Research to collect this data. In Arizona, 1,117 children were screened and 261 households completed in-depth interviews via an online survey using a blend of national consumer panels. Child-level statewide projections are based on 2011-2012 total school enrollment data from the U.S. Department of Education.
